NOTIFICATION

No. H. 20013/04/13-JERC: In exercise of powers conferred under Section 50 read with Clause (x) of Sub-section (2) of Section 181 of the Electricity Act, 2003 (36 of 2003), and all other powers enabling it in this behalf, the Joint Electricity Regulatory Commission for Manipur & Mizoram hereby makes the following Regulations to amend the Joint Electricity Regulatory Commission for Manipur & Mizoram (Electricity Supply Code) Regulations, 2013 (hereinafter referred to as “the Principal Regulations”), namely;

1. *Short title and commencement*

- (1) This Regulations may be called the Joint Electricity Regulatory Commission for Manipur and Mizoram (Electricity Supply Code) (Fifth Amendment) Regulations, 2016.
- (2) This Regulations shall extend to the whole States of Manipur and Mizoram and shall apply in relation to all matters falling within the jurisdiction of the Commission.
- (3) These Regulations shall come into force with effect from 1st April, 2017.

2. *Amendment in Definitions and Interpretations of the Principal Regulations:*

Clause (18) and (22) of the Definitions and Interpretations of the Principal Regulations shall be substituted as below:

- (18) The words “Power Factor of 0.85” appearing on the third last line shall be substituted with the words “**Power Factor of 0.90**”

(22) The words “Power Factor of 0.85” appearing on the last line shall be substituted with the words “**Power Factor of 0.90**”

3. Amendment in Table 1 of Regulation 3.2 of the Principal Regulations:

Table 1 of Clause 3.2 of the Principal Regulations shall be substituted as below:

3.2 In Table 1 of Regulations 3.2, the words “exceeding 59 kVA” shall be substituted by the words “**exceeding 55.56 kVA**”


The words at the bottom of Table 1 of Regulations 3.2, the words “Assuming a power factor of 0.85” shall be substituted with “**Assuming a power factor of 0.90**”

4. Amendment in Annexure 11.8 of the Principal Regulations:

The Note section of Annexure 11.8 of the Principal Regulations shall be substituted as below:

Note:- The words “KW = 0.85 of KVA” in the Note section shall be substituted with “**KW = 0.90 of KVA**”
