

PUBLIC HEARING NOTICE

No.02/MnERC/Tariff-MSPDCL: The Manipur State Power Company Limited (MSPCL), Imphal and the Manipur State Power Distribution Company Limited (MSPDCL), Imphal had filed petitions for determination of Aggregate Revenue Requirement (ARR) and Tariff for FY 2026-27 before the Manipur Electricity Regulatory Commission(MnERC) as per the JERC(Manipur & Mizoram) Regulations, 2024 notified under Section 61 read with Sections 62, 64 and 181 of the Electricity Act, 2003, subsequently adopted by the Commission.

2. The Managing Director, MSPCL has published Public Notice on Tariff Summary in leading newspapers (viz. The Sangai Express (English Edition) and Huiyen Lanpao (Manipuri Edition) on 17th & 18th April, 2026) of the State indicating therein their proposed ARR and Transmission Tariff for the FY 2026-27 and inviting suggestions / objections from the general public and stakeholders to be submitted on or before 27.04.2026.

3. The Managing Director, MSPDCL has published Public Notice on Tariff Summary in leading newspapers (viz. The Sangai Express (English Edition) and Sanaleibak (Manipuri Edition) on 17th & 18th April, 2026) of the State indicating therein their proposed ARR and Retail Tariff for the FY 2026-27 and inviting suggestions / objections from the general public and stakeholders to be submitted on or before 27.04.2026.

4. The Commission shall hold a public hearing on the ARR and Tariff Proposals of the Managing Director, MSPCL and MSPDCL on **30.04.2026 from 11:00 am to 2:00 pm at the Dynasty Hall, Hotel Classic Grande, Imphal.**

5. All interested parties (not more than two representatives) and individuals who have duly submitted written objection/suggestion within the specified date mentioned above may appear before the Commission to be heard in the above venue at the scheduled time. The hearing will be done along with representatives of MSPCL and MSPDCL. The Notice may also be seen from Commission's website www.mnec.mn.gov.in. The Commission shall make decision in due course considering the objections / suggestions and replies.
